Abstract. Manuscript submissions must be received electronically with hardcopy submitted by fax/mail to verify electronic submission. Electronic submission will be used for Proceedings and CD-ROM. Electronic format should be in PDF using this document as a style guide. In order to obtain a good reprint, PDF files must be optimized for printing (300dpi resolution). Graphics should be embedded in the two column text format.

I. DOCUMENT TEMPLATE

This document conforms to the instructions it contains. It is in the correct page set up and contains a set of styles to be used to control the presentation of the document. You can use its Word version as a template for your paper.

II. PAGE LAYOUT AND LENGTH

The page layout is A4 format with 2.5cm (1 inch) margins all around (top, bottom, left and right). The title and authors section are in single column format. The main body of the paper is in two column format with 0.6cm (0.25 inch) column separation. Text should be justified.

The paper must not exceed three pages for regular papers and eight pages for invited papers, including illustrations, references and appendices.

Do not include any automated page numbers.

III. TITLE AND AUTHOR

Centre the title in bold Times New Roman font (20 pt) on the first page. Please do not use "ALL CAPS."

Below the title, in Times New Roman font (12 pt), center the author's name, company or university affiliation, and complete mailing address using upper and lower case letters. Authors with different addresses or affiliations should have author information placed sequentially in the order in which they appear in the author list. Each different affiliation or address should start on a new line. The email address of the correspondence author should be included at the end of his postal address.

IV. STYLES

Table 1 contains a list of all the styles which should be used and the purpose of each style.

V. ABSTRACT PORTION OF PAPER

The paper should start with an abstract which must not be longer than 100 words. The abstract should be in bold Times New Roman font (10 pt). The abstract should highlight the main results in the paper and make clear their relative importance.

VI. HEADINGS

Use the style Heading for main headings. The style uses all caps, bold Times New Roman font (10 pt). The main headings are numbered with roman numerals.

VII. MAIN TEXT

Use the style Body for all normal text. This uses 10 pt Times New Roman font with Block justification and introduces a 0.6cm (0.25 inch) indent on the first line of the paragraph.

VIII. TABLES AND FIGURES

Immediately follow the first reference to a table or figure with and actual table or figure and number

each respective table or figure sequentially. Center the captions in italic Times New Roman font (10 pt).




Figure 1. Graphic sample

Figure 1 is an example of graphic insertion.

Please note the proceedings will be in black and white. Therefore it is important that colors are converted to appropriate gray scales in solid images. Line graphs with multiple plots should use different line style, not colors, to distinguish between plots.

IX. REFERENCES

Cite references with a number which corresponds to their appearance in the paper (i.e. reference number 1 will be the first reference cited with a single pairing [1]). Separate multiple references by commas.

Each entry in the list should use the style Reference, Times New Roman font (9 pt). The list is organized by the reference number. Note the following example:

X. SUBMISSION
